**B. MATTERS CONCERNING THE RIGHT TO REPRESENT  
THE APPLICANT(S)**

In addition, it seems that the person indicated in Box IV of the request form does not have the right to practice before the national Office of (or acting for) the Contracting State of which the applicant is a resident or national, and thus does not have the right to practice before the International Bureau as receiving Office (RO/IB) in respect of the above-mentioned international application (PCT Rule 83.1bis(a)).
