Explanations

The invention as in claims 1-11 is novel and involves an inventive step in the light of the documents cited in the ISR. None of the documents indicates or suggests that first and second terminals, third and fourth terminals, first and third terminals, and second and fourth terminals of a gyrator each have one from among a single-phase differential converter, a low-noise amplifier, and a power amplifier connected thereto.
