**Box No. V** Reasoned statement under Rule 43bis.1(a)(i) with regard to novelty, inventive step or industrial applicability; citations and explanations supporting such statement

Document 2 discloses:

a feature in which B1 Mbit/s bursts and B2 Mbit/s bursts are present in a mixed manner in data received by a station apparatus (1) (paragraph [0025]); and

a feature in which the station apparatus (1) is provided with a switching unit (11) having M inputs and I outputs, between M subscriber line interfaces (10-1, ..., and 10-M) and I intrastation/interstation interfaces (12-1, ..., and 12-I) (paragraph [0020], fig. 1).

However, none of the documents cited in the ISR disclose or suggest

the feature of having a path switching device which includes first and second input terminals and first and second output terminals, and which defines the signal path between the first and/or second input terminals and the first and/or second output terminals so as to route the inputted data signal to the first and/or the second reception units.

In addition, the feature of being provided with the path switching device would not be obvious to a person skilled in the art.
