Claims 1-10

Claims 1-5 and 8-10 lack novelty and do not involve an inventive step in the light of document 1. Claims 6 and 7 do not involve an inventive step in the light of document 1.

Document 1 (claims, paragraphs [0057]-[0061], [0078]-[0080], [0088]) indicates that, as a dental bonding material, a composition is used that contains 3-90% by weight of the total composition of filler having a mean particle diameter no greater than 20 µm, such as an

epoxy resin or a plastic powder that meet the specifications of claims 1-4 of the present application.

Document 1 does not indicate that the filler meets the specifications of claims 6 and 7 of the present application, but the use of filler made of a suitable plastic and the optimization of the filler configuration are considered to be matters that a person skilled in the art could address as appropriate. Doing so also cannot be considered to produce a prominent effect.

Claims 1 and 3-10

Claims 1, 3, 4, and 8-10 lack novelty and do not involve an inventive step in the light of document 2 or 3.

Claims 5-7 do not involve an inventive step in the light of document 2 or 3.

Documents 2 and 3 each indicate that a composition that contains 3-80 or 3-50% by weight of an epoxy resin and 3-85% by weight of a polymer powder filler, which meet the specifications of claims 1, 3, and 4 of the present application, is used to bond coatings or substrates (document 2 (claims, paragraph [0025], chemical formulas 12, 13, paragraphs [0033], [0041], examples) and document 3 (claims, paragraph [0017], chemical formulas 34, 38, paragraphs [0023], [0030], examples)).

Documents 2 and 3 do not indicate that the polymer powder meets the specifications of claims 5-7 in the present application, but the use of a suitable polymer and the optimization of the filler particle size and configuration are considered to be matters that a person skilled in the art could address, as appropriate. Doing
