## RESUMO

**CART OU ESTAÇÃO DE TRABALHO EMBUTIDA EM MALA DESTINADO PARA USO EM CENTRO CIRÚRGICO E/OU ATIVIDADES DIDÁTICAS, COM COMPUTADOR, TELAS E CÂMERA DE INFRAVERMELHO OU OUTRA PARA LEITURA E DIAGNÓSTICO MÉDICO**, consiste em cart embutida em mala (1) provida de rodas e freio (2), compartimentos internos com porta e ventilação (3), iluminação interna (4) tanto para as partes fechadas do cart como para abertas para auxiliar trabalho do operador, estação de trabalho (5) provida de servidor com interface digital e periféricos (mouse, teclado, impressora), monitor do operador com braço articulado (6), monitor do cirurgião (7) sobre pedestal móvel (8) ou junto do cart, lança (9) retrátil mecânica ou hidráulica (10) com alcance preferencial entre 1 e 3 metros, com movimentação livre dotada de contrapeso (11) que pode ser também na forma de haste disposta no interior do cart, câmera de infravermelho de alta definição (12) termográfica com anemômetro, higrômetro, termômetro para temperatura ambiente, a qual se posiciona sobre o paciente, deitado sobre a maca cirúrgica (13) e câmera para visualização do ambiente cirúrgico não infravermelha (14).
