The present disclosure relates to a computer implemented method for applying gamification techniques to a security system. The security system comprises a server connected to a computing device associated with a user/operator. The user/operator has an assigned user skill level. The server receives notifications of security events that need to be handled and based on the events determines tasks to be performed, each task associated with a task skill level. The server assigns a task to the user and receives a notification when the task is completed. Based on the task, the task skill level and the user skill level the server determines a score of performance of the task for the user.
