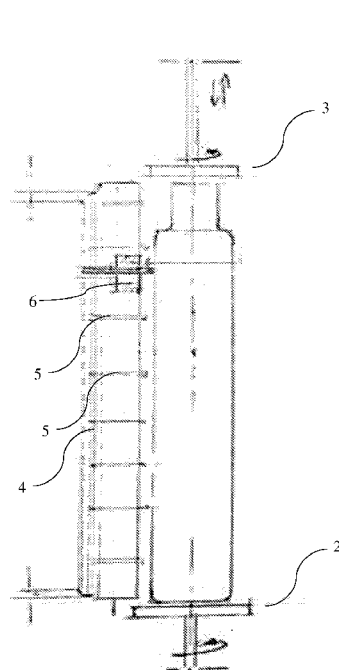

(57) Abstract: The present invention relates to a system for use in glass production technology such as for production of glass packaging, glass-ware, glass home equipments, wherein said system allows all kinds design additions such as color, pattern, texture, decor, seal and form changing processes to be applied to the product without requiring re-firing of the product, after removal of the product from the moulds in the production lines while the product is still hot and the temperature is kept constant.
