The present invention relates to cosmetic skin care compositions which comprise a hyperbranched copolymer of the monomers dodecanyl succinic acid anhydride, diisopropanol amine and bis-dimethylaminopropyl amine having quaternary terminal groups and an anionic emulsifier. The copolymer is used in a cosmetic composition comprising the anionic emulsifier for reducing the material transfer to a contacted surface. Preferably the copolymer is polyquaternium-110.
